4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Methods and material for containment and cleaning up

Methods for containment

Stop leak if you can do it without risk. Absorb spill with inert material (e.g. vermiculite, dry sand or earth). In case of large spill, dike if needed. Dike far ahead of liquid spill for later disposal.

Methods for cleaning up

Absorb spill with inert material (e.g. vermiculite, dry sand or earth). Use appropriate tools to put the spilled material in a suitable chemical waste disposal container. Clean contaminated surface thoroughly.

Precautions for safe handling
