## 6. ACCIDENTAL RELEASE MEASURES

**Methods for cleaning up** Use appropriate tools to put the spilled material in a suitable chemical waste disposal container. Clean contaminated surface thoroughly.

## 7. HANDLING AND STORAGE

### **Precautions for safe handling**

**Technical Measures/Precautions:**

Provide sufficient air exchange and/or exhaust in work rooms. Remove all sources of ignition. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from incompatible materials.
