6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Personal Precautions:

Ensure adequate ventilation. Use personal protective equipment. Avoid contact with skin, eyes and clothing. Keep people away from and upwind of spill/leak. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Remove all sources of ignition.

Environmental precautions

Methods and material for containment and cleaning up

Methods for containment

Stop leak if you can do it without risk. Absorb spill with inert material (e.g. dry sand or earth), then place in a chemical waste container. In case of large spill, dike if needed. Dike far ahead of liquid spill for later disposal.

Methods for cleaning up

Use appropriate tools to put the spilled material in a suitable chemical waste disposal container. Clean contaminated surface thoroughly.
