#### **Description of first aid measures**

<b>General advice</b>	Show this safety data sheet to the doctor in attendance. Immediate medical attention is required.
<b>Inhalation</b>	Remove to fresh air. Get medical attention immediately if symptoms occur.

## **5. Fire-fighting measures**

### **Precautions for safe handling**
