## 5. FIRE-FIGHTING MEASURES

**Extinguishing Media****Suitable Extinguishing Media:**

Carbon dioxide (CO2). Dry chemical. Water spray mist or foam.

**6. ACCIDENTAL RELEASE MEASURES****Personal precautions, protective equipment and emergency procedures****Personal Precautions:**

Ensure adequate ventilation. Keep people away from and upwind of spill/leak. Avoid contact with skin, eyes and clothing. Use personal protective equipment. Remove all sources of ignition. Take precautionary measures against static discharges. All equipment used when handling the product must be grounded. Use spark-proof tools and explosion-proof equipment.

**Methods and material for containment and cleaning up****Methods for containment**

Stop leak if you can do it without risk. Absorb spill with inert material (e.g. vermiculite, dry sand or earth). In case of large spill, dike if needed. Dike far ahead of liquid spill for later disposal.

**Methods for cleaning up**

Use appropriate tools to put the spilled material in a suitable chemical waste disposal container. Use only non-sparking tools. Clean contaminated surface thoroughly.

**7. HANDLING AND STORAGE****Precautions for safe handling****Technical Measures/Precautions:**

Provide sufficient air exchange and/or exhaust in work rooms. Remove all sources of ignition. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from incompatible materials.

Wear personal protective equipment. Use only in well-ventilated areas. Avoid contact with skin, eyes and clothing. Keep away from heat and sources of ignition. Do not breathe vapors or spray mist.
