Use explosion-proof electrical, ventilating and lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Do not breathe dusts or mists. Wash hands and face thoroughly after handling. Wear protective gloves, protective clothing, face protection.
If swallowed: Rinse mouth. Do NOT induce vomiting. Immediately call a poison center or doctor. If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water or shower. 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures:	Use extra personal protective equipment (self-contained breathing apparatus). Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.
Environmental precautions:	Prevent product from entering drains.
Methods and materials for containment and cleaning up:	Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
Prevention of secondary hazards:	Do not allow contact with water. Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

7. HANDLING AND STORAGE

Keep away from heat/sparks/open flame/hot surfaces. -No smoking. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid contact with skin, eyes and clothing. May develop pressure. Open carefully. Use corrosive resistant equipment.

Storage conditions:	Keep container tightly closed. Store in a cool, dark and well-ventilated place. Store under inert gas. Protect from moisture. Store locked up. Store away from incompatible materials such as oxidizing agents. Light-sensitive Moisture-sensitive
