**[Prevention]**

Use explosion-proof electrical, ventilating and lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Do not breathe dusts or mists. Do not eat, drink or smoke when using this product. Wash hands and face thoroughly after handling. Wear protective gloves, protective clothing, face protection.

**[Response]**

If swallowed: Rinse mouth. Do NOT induce vomiting. Immediately call a poison center or doctor. If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water or shower. Immediately call a poison center or doctor. Wash contaminated clothing before reuse. If inhaled: Remove person to fresh air and keep comfortable for breathing.
